The minutes for the March meeting were distributed and reviewed. A motion to accept the minutes was approved.

## Treasurer's Report:

- Letter from the Working Lands Alliance. Our Council is a sponsoring member. Clyde Breakell moves to, (authorize the Council Treasurer to make a \$100.00 donation to WLA in the anniversary month of our sponsorship.) There was a second. Motion approved.

## Website:

Chris reports that Dave Coons has updated the website with all CAC and Council reports that are available to date. May still need to delete the Northfield Club, as this club is no longer in operation.

Membership: Need list of all clubs and addresses. Clyde reports that NW R&G is trying to find a delegate for the club.

# Conservation Advisory Council: (CAC)

- Chris reported on the inland fisheries regulations proposals. Discussion centered on the proposal to limit trout fishing on several of the Trophy Trout Lakes due to high trout mortality during the warm weather, summer months. The regulation proposals will be available on the DEP website and there will be a public hearing later this summer.
- Further discussion revolved around the complexity of fishing regulations and the loss of fishing license sales in this state over the past decade.
- A winter flyover deer survey was conducted in 2005-6. Results are being assessed by DEP and should be available soon.
- The Sunday Hunting Bill is reported stalled in the house because of amendments. It has now become
  controversial, and as a result, may not be called for debate before the legislative session ends.

### Old Business:

- Chris reports that we have the combo for the south gate of the Goshen WMA. We need to plan
  work parties for habitat work and cleanup.
- Jim reported on the Burlington Hatchery and progress on getting wetlands approvals for the wells.
- Tickets for the Council Raffle will be available next week at Autumn Gun Works.
- Dom reported on the Metacon issue. Plans for our Council visit on Sunday were made.

#### **New Business:**

- Chris reported on the formation of an Open Space Committee in the Town of Goshen and efforts
  by the town to establish an open space fund for future use. Sportsmen on this committee are
  urging that recreational opportunities and active woodland management be included in the
  planning wherever reasonably possible.
- Chris also reported on efforts to purchase the 300-acre Kelly Farm for open space.
- Mike Fusco reported that Harwinton R&G is going to host a Range Safety Officer Class. Any club wishing to have members attend this class can contact Mike to make arrangements.
- Torrington Conservation Committee and NW TU are conducting a Naugatuck River Cleanup on the second Saturday of June. Meeting area will be the Torrington Senior Center on East Albert St., and the cleanup will progress south to Campville. Dumpsters, tools and refreshments will be provided.
- Dom reported on the "Lost and Stolen Gun Bill. This bill was discussed in depth and disappointment was expressed that some of our area legislators actually support this bill.
- Dom reported on Metacon's. "Women On Target" program. Flyer's available.
- Seamus reported that Rocky River will be holding its Coon Hound Field Trials and hunt Saturday.
